What is a 1095-B Form?

The 1095-B form is provided to individuals by insurance carriers. It has details like the type of coverage, the months in 2020 your employees had insurance and the names of those covered by the plan.

BlueChoice is required to provide this form by the Internal Revenue Service for tax purposes every year.

How to Access 1095-B Forms

Your employees' 2020 1095-B will be available on My Health Toolkit in early February. **They will not receive a mailed copy.**

For your employees to access their 1095-B forms, here's what they need to do:

1. Visit www.BlueChoiceSC.com to log in to their My Health Toolkit account. *If they don't have a My Health Toolkit account, they can create one by clicking the "Register Now" button on the [BlueChoiceSC.com](http://www.BlueChoiceSC.com) homepage and following the prompts.*

2. Once logged in, they should navigate to the “Quick Links” section on the home screen and click on “Tax Forms.”
3. Their 2020 1095-B form can also be found under “Resources” at the top of the screen.

If they are signed into the My Health Toolkit mobile app, they will need to access the full site from the main menu to view their 1095-B.
